ABOUT THE TAX PROGRAM

As a result of A.R.S.108,01, the AZ Department of Revenue has issued guidelines which allow an income tax credit for contributions to extracurricular programs in public schools in the following amounts:

- \$200 for single individual
- \$200 for head of household
- \$400 for married couple

It is not a requirement that the taxpayer have a child enrolled in a public school.

Most Commonly Asked Questions?

Can I still contribute to the school if I already paid more taxes through payroll deduction than I owed and I'm now due a refund?

You can receive an additional \$400 back on your refund, provided your total tax liability is at least \$400 in the first place.

What if I owe additional money for state income tax?

You may take a credit up to \$400 from your taxes owed.

Example

If a total of \$1000 was withheld from your earnings during the year, and at tax time your Arizona Income Tax liability was only \$700, the AZ Dept. of Revenue would refund you \$300 without a school tax credit.

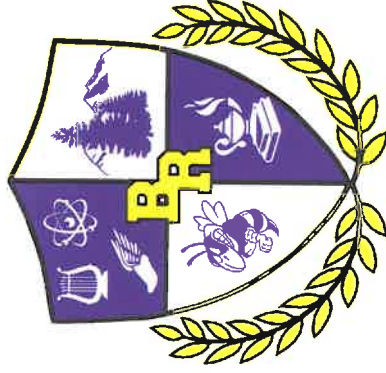
Your Refund Check: \$300

If, however, you had contributed \$400 to a public school, the AZ Dept. of Revenue would refund you the \$300-- PLUS another \$400 refund for the school tax credit.

Your Refund Check: \$700

If a total of \$1000 was withheld during the year and your total Arizona income Tax liability was \$1400, you would owe \$400. With the \$400 tax donation.
